#### **Reconfirmation Meeting for November 2020**

#### Reconfirm the current instructional delivery method:

All Mason elementary schools (10/19/20) and Mason Middle School (11/2/20) transitioned to in-person learning using a hybrid model (2-day in-person alternating) while maintaining a fully remote distance learning model for families electing to keep their student(s) remote.

Students in grades 9-12 will be provided the option of in-person learning using a hybrid model (2-day in-person alternating) or a fully remote distance learning model at the start of 2nd trimester (11/30/20).

Currently, grades 9 to 12 students are following the distance learning model as outlined in the <a href="COVID-19">COVID-19</a>
<a href="Preparedness">Preparedness and Response Plan</a> that the Mason Board of Education adopted on 8/10/20.

# Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

Grades K-8 special education basic classrooms will transition to four, full days of instruction with Wednesdays being fully remote. The middle school made the transition to four, full days on November 2, 2020 and the elementary classrooms will transition on November 16, 2020.

The high school classrooms will follow the same 2-day, in-person alternating hybrid schedule as the rest of the high school beginning 2nd trimester (11/30/30).

The model for basic classrooms will be re-evaluated every 30 days.
